SWINDON BOROUGH COUNCIL

(WAITING AND LOADING RESTRICTIONS AND PARKING PLACES CONSOLIDATION ORDER 2021) EXPERIMENTAL ORDER (NO. 1) 2024

Swindon Borough Council in exercise of the powers under Sections 9 and 10 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 (the Act of 1984), as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:-

- 1. This Order shall come into force on the 1 August 2024 to remain in force until the 30 January 2026 and may be cited as the Swindon Borough Council (Waiting and Loading Restrictions and Parking Places Consolidation Order 2021) Experimental Order (No. 1) 2024.
- 2. Whilst this Order continues in force the provisions of The Swindon Borough Council (Waiting and Loading Restrictions and Parking Places Consolidation) Order 2021 (hereafter referred to as the 2021 Consolidation Order) shall apply but are varied as follows:
 - A) The plans marked tile reference CO32, CP32, CP33 and CQ33 attached to the 2021 Consolidation Order shall be suspended and replaced with the plans tile reference CO32, CP32, CP33 and CQ33 attached to this Order for the duration of this Order.
 - B) The effect of the Order is as follow:

Revocations

No Waiting At Any Time - Inverary Road (north east side)
No Waiting Mon-Fri 8am to 6pm - Inverary Road (west side)

Introductions

No Waiting/No Loading Mon- Fri 8 am – 9:30am and 2:30pm – 4pm - - Inverary Road (East Side)

School Keep Clear Markings where stopping is prohibited Mon – Fri 8am to 5pm - Boness Road (north-east side) and Inverary Road (East side)

No Waiting At Any Time - Boness Road (south-west, north-west and north east sides), Kennet Road (east and south-west sides), Inverary Road (east and west sides) and Kerrs Way (north, south and west sides)

No Waiting Mon-Fri 8am-9.30am and 2.30pm-4pm - Inverary Road (east side)

- C) Under Section 10(2) of the Road Traffic Regulation Act 1984, the Head of Strategic Transport or any other person authorised by them may modify or suspend the operation of this Order or any provision of it if it appears to be essential:-
- (a) in the interest of the expeditious, convenient and safe movement of traffic
- (b) in the interest of providing suitable and adequate on-street parking facilities or
- (c) for preserving or improving the amenities of the area through which any road affected by this Order runs.

This power shall be exercised only after consulting of the appropriate Chief Officer of Police and giving such public notice as the Secretary of State may direct.
